OPENING OF THE PRESS ACCREDITATIONS - CRIMINAL CHAMBER PARIS COURT OF APPEAL- « RUE TRONCHET CASE »

Paris, March 14th 2025

From April 28 to May 23, 2025, the trial of MM. Yunice ABBAS, Aomar AIT KHEDACHE, Harminy AIT KEDACHE, Marceau BAUM-GERTNER, Pierre BOUIANERE, Marc BOYER, Marc-Alexandre BOYER, François DELAPORTE, Didier DUBREUCQ, Christiane GLOTIN, Florus HEROUÏ, Gary MADAR, will be held at Criminal Chamber of the Paris court of appeal, for organized gang robbery with the use of a weapon, arrest, kidnapping, unlawful detention or arbitrary detention of several people, and participation in a criminal association with a view to preparing a crime, to the detriment of Ms. Kim Kardashian and other people.

The hearing will be held at the Court of appeal of Paris, located at the following address : 8 Bdv du Palais, 75001 Paris, in the courtroom « salle Voltaire ».

It will start at 9.00 am each day.

The detailed schedule for the hearing is not yet known.

In order to facilitate the organisation, an accreditation procedure is opened from today until 5 April 2025.

It will allow journalists access to the courtroom, and the use of their phones and laptops.

Journalists, editors and cartoonists wishing to access the courtroom must apply for accreditation in this trial by filling out the following form [HERE](#)

The accreditation process will end on **April 5th at midnight**.

Image reporters and technicians are also concerned by the accreditation procedure.

It is necessary to make one request per person who will cover the trial.

For journalists who do not have a press card or who have a press card as an "honorary journalist", a certificate from their employer or the editorial office for which the freelance work is carried out and including the company's legal notices as well as the names and contact details of the head of department is essential to obtain accreditation.

As the number of benches reserved for the press in the courtroom is limited, a live broadcasting of the trial is planned in the Première chambre civile of the court of appeal each day of the hearing.

Access to the courtroom will be in order of arrival : once the number of places reserved for the press has been reached, journalists wishing to attend the hearing will be invited to move into the Première chambre civile.

The size of the courtroom may not be able to accommodate all the cartoonists, so access to the room will be on a first-come, first served basis each day.

Without accreditation, use of phone and laptop are strictly forbidden inside the courtroom and the broadcasting room.

No picture shall be taken inside either rooms.

Accreditation badges will be handed in front of the courtroom on the following dates :

- Wednesday 23th of April from 9.30 am to 4.30 pm
- Thursday 24th of April from 9.30 am to 4.30 pm
- Monday 28th of April, at the trial opening and during its duration

A press kit, including practical information about the hearing will be sent to accredited journalists a few days before the hearing.
