## Ventilation des réponses pénales

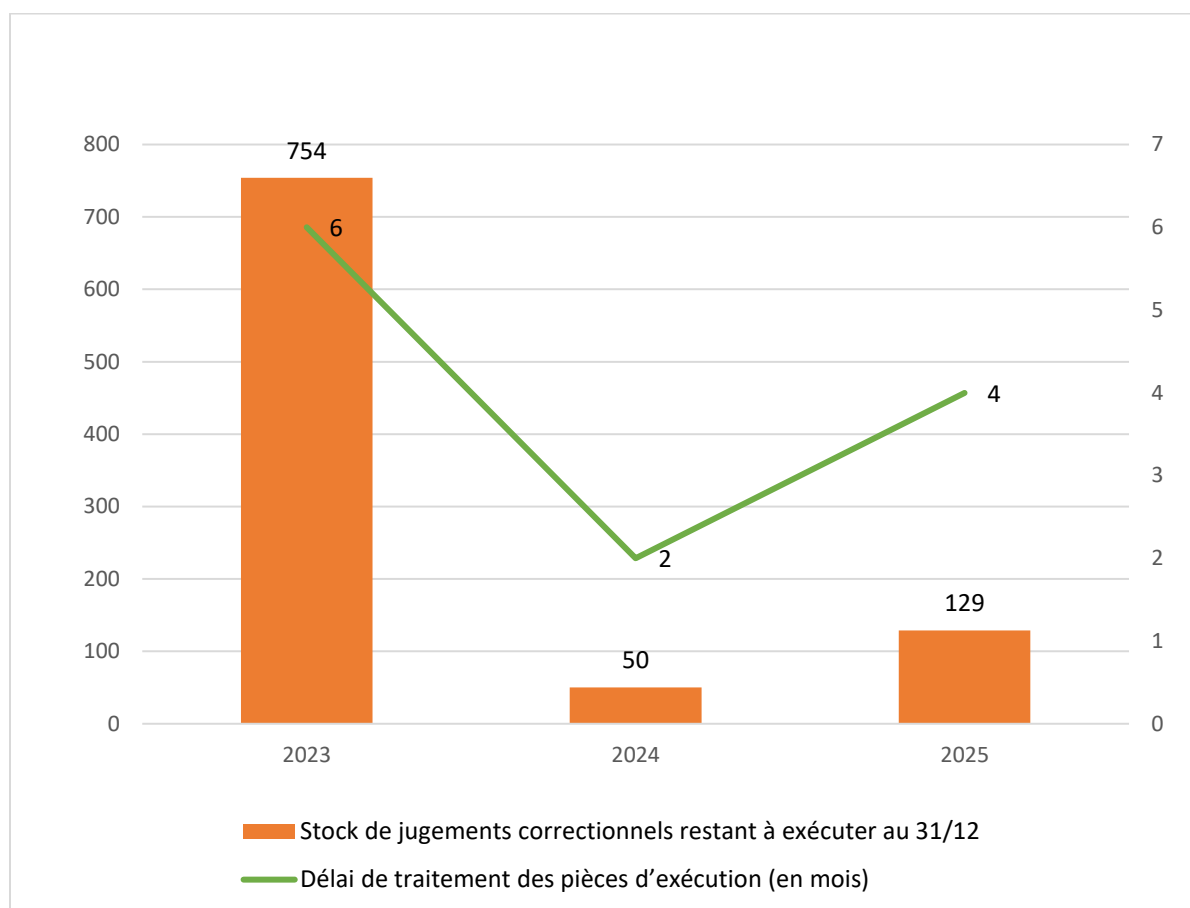

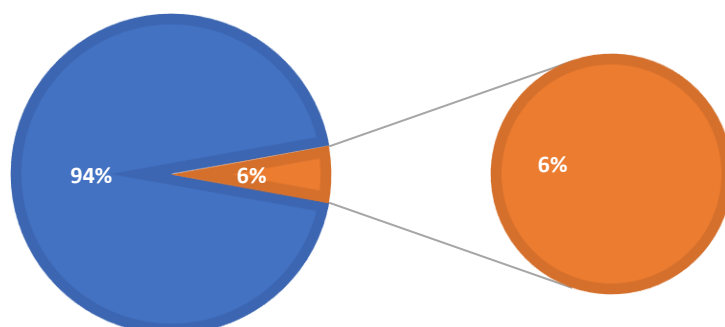


## Numéraires Produits financiers Ventes Agrasc et Domaines Total en 2025
